## Alexis Nakota Sioux Nation Message from Alexis Chief and Council

Abawashded Metodebi,

This report is presented to the Alexis members during the 3rd Quarter / Special Band Meeting on Friday, December 3, 2021 of the 2021-2022 fiscal and operating year. The report accounts for our office and activities.

As we approach the end of 2021, we want to acknowledge all the families who have experienced deep loss this year. We know it's very difficult to lose a loved one. As leaders, we do our best to support families in times of need, and we hope you are taking the time to grieve and heal. Our condolences go out to all of you, you are always in our prayers. We have included a list of resources in this report for members to access. We also want to share some news regarding an upcoming event that we hope will support families and members in need of support.

In this reporting period, we highlight the following information:

- **TD Wealth Presentation:** This presentation is part of our Treaty Land Entitlement (TLE) Trust Agreement and requires members to vote on the earnings of our TD investments.
- **Backwoods Dividends:** This income is part of our business investment from Backwoods. We have been developing our governance for the Trust and will be sharing those updates in the new year.
- **Amendments to the Customary Election Regulations (1997):** Our legal team is currently updating the changes from our September review. We intend to call a Special Meeting to vote on the amendments during the March 2022 Band Meeting.
- **Alexis Healing Gathering (2022):** We are working with YTC Mental Health to host a Healing Gathering in the new year to support members with grief and loss. We will be inviting our Elders and professionals to help guide us in this process. Members will be informed on how they can participate soon. This is a huge undertaking and we anticipate positive step towards healing and recovery. We ask for your prayers and support.
- **Peace Officer By-law:** As mentioned in our September 2021 report, we were approved for a Community Peace Officer. Part of that approval requires the nation to have a by-law specifically for the Peace Officer. The Council has a draft by-law for review. We hope to gather with the community in January of 2022 to go over this by-law and pass it so that we can legally sanction our Peace Officer.
- **Pasa Tibi Center:** This project is the Alexis Elders Independent / Assisted Living Center Project (2020-2022) which is now in the 2nd stage of development.
- **Traditional Healing Center:** This project is now moving into the 2nd phase of development with architectural planning and costing in process.

## Alexis Nakota Sioux Nation COVID19 UPDATES



### TOTAL CASES REPORTED (March 2020 – December 3, 2021)

First case reported on October 24, 2020

- 4 active cases reported in Alexis #133 Reserve. The Delta Variant is in the community (updated December 3 2021). Please be aware that there is a new Variant in Canada, Omicron.
- Total on Reserve recovered cases: 252
- COVID -19 Vaccinations (2 doses): 617
- Total deaths due to COVID-19: 5 (1 on-reserve, 4 off-reserve).
- Total swabs completed NOV 19-26, 2021: 9

### MANDATORY VACCINE POLICY:

Public health restrictions to reduce transmission are now in effect. Operators do not need to apply, but must follow or exceed the program requirements at all times, including requiring all patrons aged 12 and over to provide valid:

- proof of vaccination, or
- proof of a privately-paid negative rapid test result taken within 72 hours of service, or
- documentation of a medical exemption

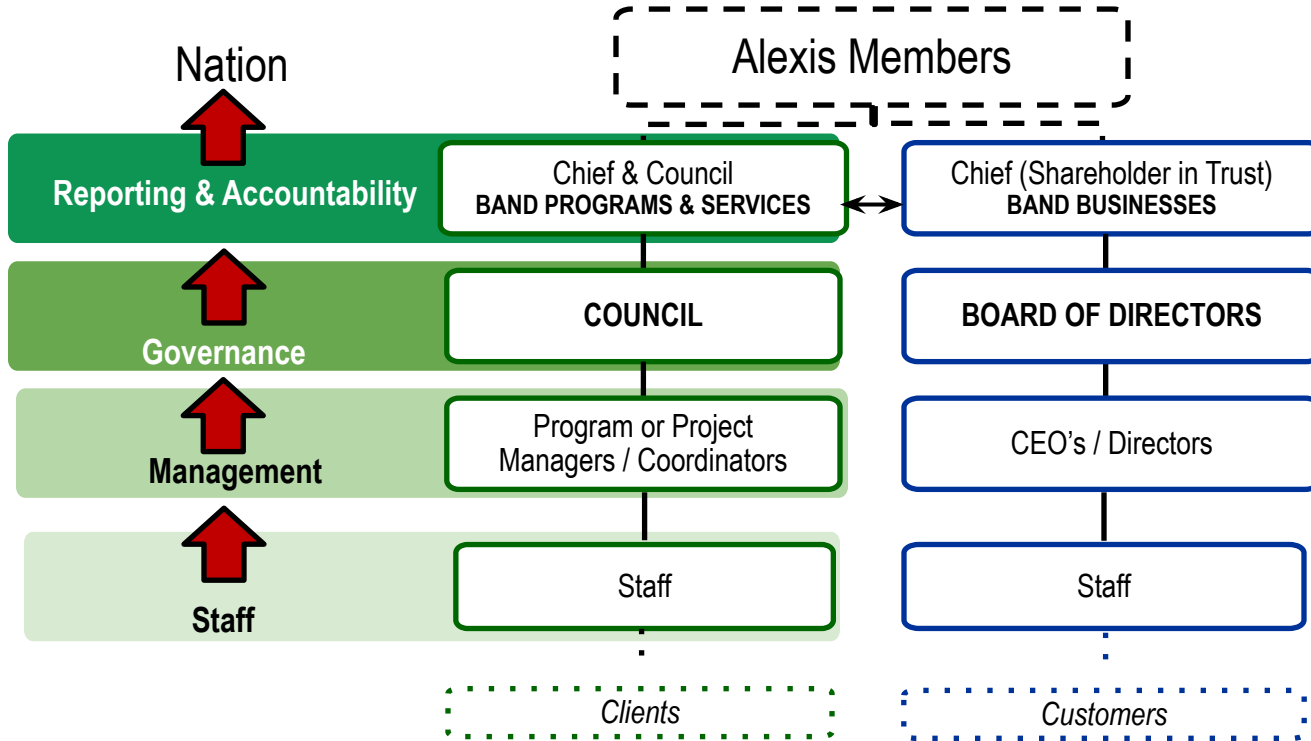

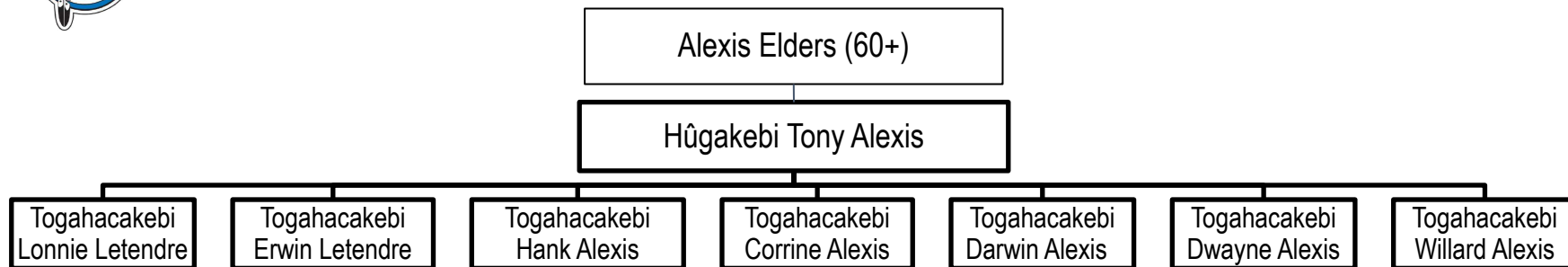
# Alexis Nakota Sioux Nation Protocol Chart

#### Research

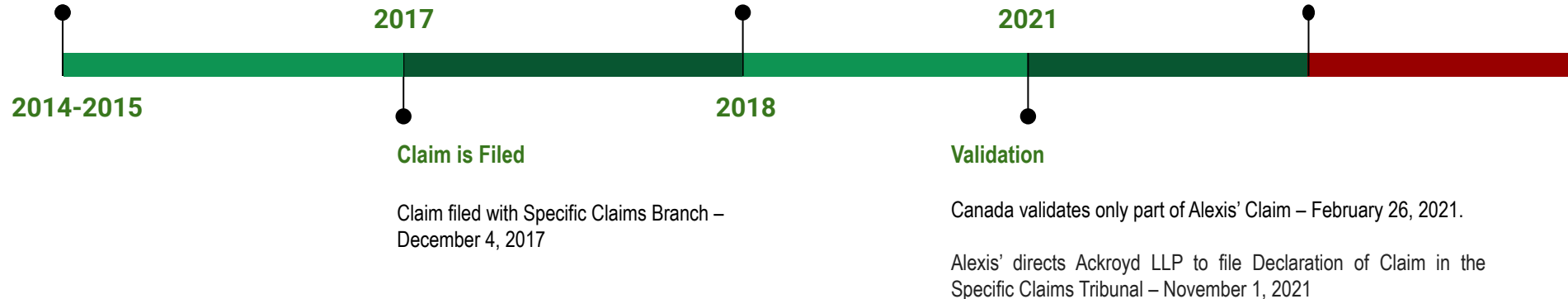
Chief Alexis secures agreement with Ackroyd LLP to begin researching Alexis' Agricultural Benefits Claim.

A BCR has been submitted directing Ackroyd to process our "Declaration of Claim" – December 2, 2021





## Alexis Nakota Sioux Nation Governance & Accountability Update

Miller Thompson, LLP and Chasidy Alexis, MA - Policy Analyst for the Alexis Nakota Sioux Nation, are assisting the Council with the amendments to current laws and drafting of new laws. The following is an update on the status of our band laws:

### 1. Alexis Constitution Law

- August 25, 2020: A draft "ANSN Constitution Law Outline" was presented to Council.
- May 20, 2021: Elders meeting held virtually and broadcasted on the radio.
- August 4 & 5, 2021: Elders Meeting at Cardinal River Camp. (Discussion on Election Regulations & Treaty Research)
- Due to recent funerals, our Elder Constitution meetings have been put on hold. (Meetings will resume in January of 2022.)

### 2. Alexis Customary Election Regulations Law

- September 7 - 9, 2021: Council met with Aiyaz Alibhai of Miller Thompson LLB regarding amendments.
- September 29, 2021: Updates provided to Alexis Members.
- The Council is going to issue a Special Meeting Notice to invite members to read and to vote on the amendments. (March of 2022)

### 3. Alexis Education Law

- We are currently working on a new Treaty Based Education Agreement. Shannon Alexis has been tasked to do the research. Details to follow.

### 4. Alexis Child Welfare Law

- We are currently working on a new Child Welfare Agreement specifically for Alexis. Verna Potts has been been tasked to do the research. Details to follow.

### 5. Alexis Band Employment Policy

- Miller Thompson LLP and Alexis HR Manager has updated our Employment Policy to include COVID guidelines. All staff will be notified of the changes.

### JUSTICE UPDATES BY COUNCILLOR DARWIN ALEXIS

#### Peace Officer By Law

The Alexis Nakota Sioux Nation received employer status from SOLGEN (Solicitor General of Canada) to employ Peace Officers on the reserve lands, # 133, 232, 233, & 234. Peace Officers will provide community based services, protection, and safety within jurisdictional and traditional boundaries of our community. Part of this process requires the Council to approve a Peace Officer By Law prior to the hiring of the Peace Officer. A Community Consultation to review the Proposed Band Peace Officer By-Law will take place on:

**Location:** Band Hall

**Agenda:** Information Session (Reading of the Proposed By-Law)

A Special Meeting Notice will go out to the community following today's meeting. We look forward to seeing you.

Last spring a decision was made to transfer our policing resources from Mayerthorpe Detachment to Parkland Detachment (Spruce Grove). As of right now, we are still receiving services from Maythorpe. #### CCG (Community Consultation Group)

On November 1, 2021 we posted an invitation to Alexis Members to volunteer on the Community Consultation Group (CCG). The CCG is entrusted with the responsibility of helping police officers understand Alexis culture and traditions. On November 30, 2021, we only received two (2) letters of interest from community members. We require 3 more members. #### Governance:

- The Board meets quarterly.

- Ryan McQuilter has retired from Backwoods.

#### Overall YTD Activity:

- Backwoods is now one of the largest (top 5) First Nations owned construction companies in Alberta.
- The business is busy, and all divisions are executing work. Work is taking place from Manitoba, into the lower mainland of BC and north to the Territories border. Backwoods has approximately 650 people employed, which fluctuates from time to time as projects start up or wind down.
- Backwoods is on budget for 2021 and has significant work in backlog in 2022 lined up.
- Due to the Covid-19 restrictions, all office staff are still working from home.
- A new co-ordination effort will be in place in the new year, as a one stop for Alexis's members to call for work opportunities. A bulletin will be sent out in the new year to the nation with the contact information.

#### Clearing Division:

Backwoods has forestry activity taking place in the following projects:

Backwoods has two full lines of forestry equipment, and both are fully engaged and working.

#### Civil

Backwoods has civil works taking place at the following projects:

- Keyera Cheecham (Conklin)

- Trans Mountain Pipeline
- TransCanada Pipelines

Backwoods will be cleaning up the spill on the Pembina line at Whitecourt in 2022, which will be a large job.

#### Matting Division:

- Backwoods is now one of the largest matting suppliers in Alberta.
- Backwoods builds its own mats and installs and maintains over 250,000 mats around Western Canada. This is managed by the Acheson facility.

- Mats are being supplied into every major project in Western Canada including Trans Mountain, TC Energy and Keyera.
- Work is increasing in the midstream markets with oil prices improving from previous years.

- We are also assisting Alexis in the cleanup of the abandoned wells on Alexis Reserve #133.

### UPDATE:


- SLOTS – Saw strong play prior to vaccine passport implementation.
- TABLE GAMES - Saw strong play prior to vaccine passport implementation.
- FOOD & BEVERAGE - Food and beverage sales continues to recover; it was the area of operations most impacted by social distancing requirements.
- HUSKY - Travel Plaza operations have been steady and growing during this time, often achieving pre-lockdown budget targets.

While the past few weeks have been challenging due to the vaccine mandate, the property has done very well in consideration of the challenges that it faced. In fact, prior to the announcement of Alberta's latest restriction, the casino was tracking toward achieving its pre-Covid budget.

### GOING FORWARD:

The seasonally slow period for the casino has been compounded by the effects of the Covid pandemic. Sots and tables have seen a fall off in revenues. The expectation is that this will persist to the end of the year and into early next year, with a return to business as of March 2022. Given this expectation, the casino will be investing heavily in marketing and promotions in 2022, with the first concert of the year scheduled in March and vehicle giveaway promotion for the last half of the year.

Jodie Jones will be attending Alexis monthly from December 3<sup>rd</sup>, 2021, to try to increase the casino's visibility to younger candidates who may consider a career in gaming.

## Alexis Nakota Sioux Nation Education Board Update

### **UPDATE BY: TONI LETENDRE, MA, EDUCATION DIRECTOR**

#### **Operations:**

Our finance clerk left the department for a new position as of October 29th and we had a special appreciation luncheon for her. We had a transition in roles at the administrative level and we placed our previous receptionist into the finance role. Our new finance clerk was trained, enrolled and completed courses for the new position. 98% of Education staff are vaccinated with at least 2 doses of the moderna vaccine. Those staff who are not fully vaccinated must do a rapid test before starting work every sunday. The ANSN School started implementing the Rapid Antigen tests with employees as a preventative measure to keep the school open. The Re-entry plan to covid has been updated to reflect cases on nation.

- 1-5 cases in the nation school will remain open
- 5-10 cases in the nation, school will implement cohort model
- 10-20 cases in the nation school will close and resume online learning through google classroom.

#### **Alexis School/Chief Aranazhi School:**

The school has been in full operation since October 5th. We have seen an increase in enrollment this year. Student Absences/ Alternative Programming A number of our High School Students have already exceeded the maximum number of absences in a term to qualify for credits in their coursework. This is not just in single subjects but across all courses they are registered in. Based on the historically high number of students who have repeatedly failed to attend high school consistently enough to earn credits, we need to carefully review our current accommodations for these students. The current Alternative Program based in the training centre has only one registered student.



#### **Visitors:**

The education department is currently implementing the exemption program as introduced to the province. Anyone who enters the building must provide QR code or proof of vaccination. If they are not vaccinated, they must provide proof of a negative test within 72 hours and do a rapid antigen test before leaving the front office.

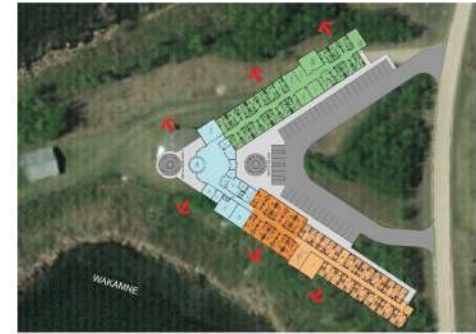

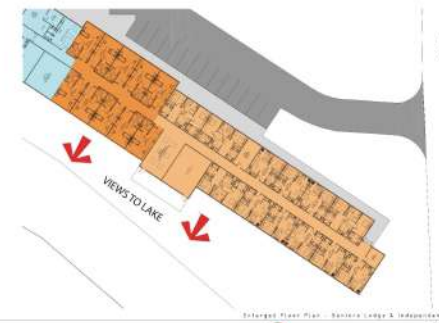


Enlarged Site Plan

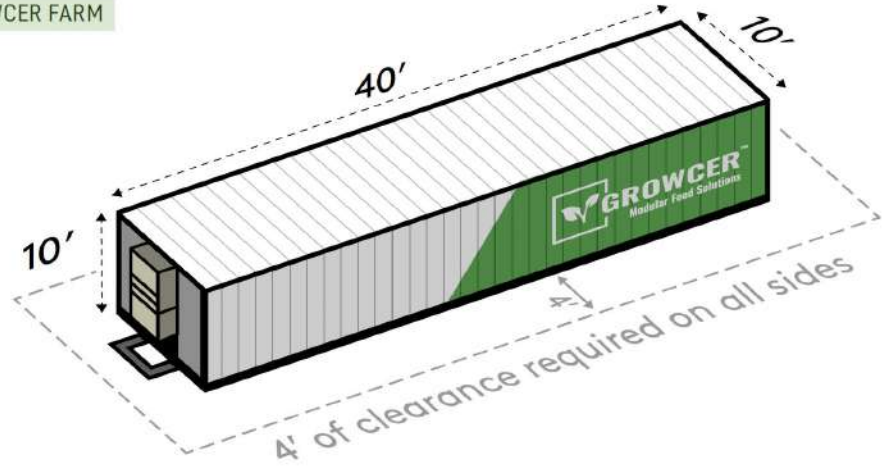

The Council has concluded the State of Emergency Order and has authorized Duane Kootenay, Tracy Potts, Dale Alexis, Paul Q. Kootenay & Crystal Potts to continue their roles. We would like to thank the rest of the committee for their service on the committee: Jasmine Alexis, Charlene Stroeder, Carrie Ann Alexis, Shelly Nelson, & Lorraine Mustus.

The following report was provided by Jasmine Alexis.

- At this time the ERT is still planning for Covid-19 Pandemic and is now in the recovery phase. We currently have 7 members working ongoing with assisting in deliveries of PPE and food security.
- As of November 24, 2021 Here are the ongoing projects of the emergency response team: Childrens Covid-19 vaccinations ages 5-11 is not mandated yet to be determined. Booster shots available for on/off reserve members by appointment only.
- Proposal for 2nd harvest funding has been completed and submitted for \$100,000 November. 24. 2021
- \$275,000 was received for food security ICSF Q4.
- Homeless are being fed from Monday-Friday by Daycare staff. The food is currently being delivered to the members.
- Remaining funds will be allocated for food security.
- Local state of Emergency hasn't been lifted.
- Currently planning for 5th wave of Covid-19 is in progress.
- **The Province will see inflation of food in the next coming month due to the disaster in BC. We are urging members to make sure food is always stocked.**

Recently our team installed a new instrumentation tower to provide safer access for field technicians and easier maintenance.

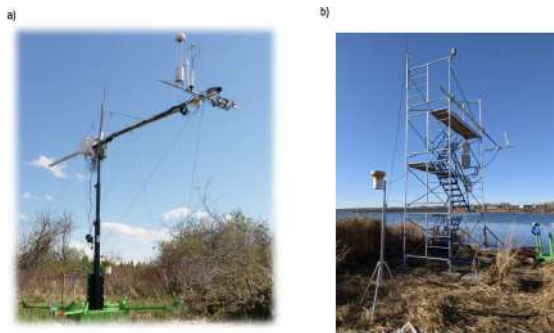

- Nitrate
- Dissolved oxygen
- Water temperature
- Turbidity

**Stationary water quality sites:** A new water quality and climate station was installed on Sturgeon River between Waka Mne and Lake Isle (August 2021) (Fig 2)

**Drone (i.e., UAV):** Our field technician will soon be flying a UAV over ANSN lands, equipped with:

- LIDAR sensor
  - Maps vegetation
  - Maps buildings
  - Maps soil surface
- Thermal camera
  - Wildlife counts
  - Search and Rescue

### Traditional knowledge and perspectives

**Elder and youth interviews:** Performed 12 podcast-style interviews (1-4 hours long) which will be:

- Edited
- Released on social media (with consent)

Drafting community surveys to understand community-wide perspectives:

- Climate change
- Water quality
- Environmental health

### Data management

#### Data storage and archiving

Installed an independent data cloud (like Google Drive; only accessible by team members) with help from Garth McDermott (**Error! Reference source not found.**).

Many benefits:

- ANSN data not accessible to external stakeholders
- Strong collaboration platform
- Increased document and data organization
- Automated backups to an off-site location (prevent data loss due to natural disaster)

#### Database, analysis, and visualization programs

Our team is drafting programs to:

- Automatically construct a database with all GHG, water quality and climate data
- Automatically perform data analysis on database
- Automatically Create graphs of GHG, water quality and climate data
