

Alexis Nakota Sioux Nation Tribal Administrator Update

I am pleased to provide an update for the quarterly meeting.

My role involves working directly with the Council to ensure that Band Programs and Services are delivered in accordance with the budget, approved work plans, and accounting standards. Additionally, I collaborate with the Financial Supervisor to ensure that all financial matters are managed, reported, and accounted for in compliance with the ANSN Financial Management Policy.

Since April 3, 2024, I have also been serving as the Interim Director for the ANSN Child Family Wellbeing Program, and since June 4, 2024, as the Interim Manager for ANSN Housing. In these managerial positions, I adhere to the duties specified in the nation's policies and follow Council-approved work plans and budgets. Furthermore, I am actively involved in the Indigenous Justice Committee with Justice Redman. The upcoming meeting, which will be the first inperson event, is scheduled for June 20, 2024, in Red Deer, Alberta; previous meetings have been held virtually.

I am a committed and dedicated member of the Alexis Nakota Sioux Nation.





Alexis Nakota Sioux Nation Agricultural Benefits Claim





Was intended to support Agricultural Activities on our lands



Specific Provision of this clause were NOT met by the Crown

- ANSN has received an offer to settle its claim for Agricultural Benefits
- A ratification Vote on the Settlement Offer will be held on the 26th of July 2024 at Alexis#133 RESERVE near Glenevis, Alberta
- As part of our strategy, the nation has engaged a team to provide information.



Alexis Nakota Sioux Nation Agricultural Benefits – Key Points

1. What is Cows and Plows?

Treaty No. 6 was negotiated and made with the Queen in 1876. A key promise made under Treaty No. 6 was Canada's promise to provide assistance to First Nations that would encourage a transition from a predominantly hunting based livelihood to a Euro-Canadian agriculture and/or stock raising economy. Treaty claims based on this promise are commonly referred to as "Cows and Plows".

2. When Did ANSN Commence its Cows and Plows Claim?

After having expert historical reports completed in 2016, ANSN's legal counsel filed a claim with the Specific Claims Branch in 2017. The Specific Claims Branch considers claims made by a First Nation against the federal government which relate to the administration of land and other First Nation assets and to the fulfilment of Indian treaties, although the treaties themselves are not open to renegotiation.

In 2021, ANSN received a partial validation of its Claim. As Canada only offered to negotiate part of ANSN's claim, ANSN filed a claim in the Specific Claims Tribunal in 2021. ANSN also filed a claim with the Federal Court in 2022. This action was put into abeyance later that year.

3. Has Canada Now Agreed to Negotiate the Entire Claim?

In January 2023, ANSN agreed to enter into the accelerated negotiation process under Canada's new expedited resolution strate gy. To facilitate negotiations, the Agricultural Benefits Committee (ABC), along with legal counsel, attended intensive and positive negotiations with Canada.

4. When will the Claim be Settled?

ANSN and Canada reached a tentative deal with respect to compensation in late 2023. On March 5th, 2024, Canada made a formal offer of settlement. ANSN is now preparing for a ratification at which time ANSN members will get to vote on the settlement offer. Community Information Meetings will take place before the vote to explain the proposed settlement offer and answer any questions posed by members.

5. Why is Information with Respect to the Claim Confidential?

As part of the process of entering into negotiations with Canada, ANSN was required to sign a Non-Disclosure Agreement. This means that, while information with respect to negotiations can be shared with Members, information cannot be shared in the public sphere.



Alexis Nakota Sioux Nation Agricultural Benefits – Proposed Use of the Settlement Funds

Immediate Disbursement:

Leadership has proposed to take a two-phased approach to the distribution of the Agriculture Benefits Settlement.

- A disbursement of \$50,000 to every member of the ANSN.
- The remaining funds will placed into a Trust Legacy Savings Account, which will be locked in for a period of 20-years.

Alexis Nakota Sioux Nation Education Board Update




The Alexis Board of Education was incorporated on **September 14, 1990**. The Alexis Board of Education Policy Handbook was created in **May 2001** and provided an organizational chart. The current organizational chart has been updated to include a Vice Principal and department heads. The Education department is currently updating Education Policy to reflect new education act. The Education Board is currently undergoing research and visiting surrounding nations regarding Transformation Funding formula and REA. The board of Education Went to visit with Alexander First Nation on the February 23, 2024. Currently Alexander is in the same position as Alexis regarding funding formulas. There was a meeting scheduled for Sunchild First Nation but due to inclement weather we were unable to attend. We will be rescheduling this meeting for the next couple weeks. The Education Board will be doing more school and nation visits in the new fiscal year. I have attached a fact sheet from AFN to reflect the current nations that have signed REA and Nations that are Treaty based.

Policy & Mandate

The Alexis Board of Education hosted its annual AGM on April 20-24th. The Education Board is currently undergoing research and visiting surrounding nations regarding Transformation Funding formula and REA. The Board of Education met with Indigenous Service Canada to discuss the new Interim Regional Funding Formula.

OHS Procedures & Safe School Initiatives

Alexis Education is committed to providing a safe environment for staff and students. We have made sure to have routine drills such as fire and lockdowns. We have installed Mustard Point signs in all areas so promote safety and procedures. We have included bathroom signs for all genders to have adequate space for all. Alexis Education met with the Emergency Management Manager, Fire Chief, RCMP, YTC EMT Rep, and Education Board Chair to meet over safe school initiative.

This year was the first in our nation's history having the participation with our local RCMP detachment to conduct our safe school lockdown. The RCMP had a great time with the elementary students. Alexis Education is focused on providing a safe school environment. The RCMP have been making weekly visits, along with Backwoods Security. We want to ensure our students and staff feel safe when they are on school property.

Community Engagement & Parental Involvement

Alexis Education hosted a parent summit on May 14th regarding Trauma, learning loss, Literacy results, numeracy results, and Attendance matters campaign.

Literacy Support Program:

There are currently 50 students receiving pull-out service from Mrs. Dallmann and Emjay Petawaysin. Students have been tested three times in 2023-2024 (September, January & May) to assess growth. Various programs and resources are utilized within the program, including Phonics

Companion, Phonemic Awareness, Heggerty, Fry's Words, Handwriting Without Tears and Fountas & Pinnell LLI. Reading assessments are completed three times per year in September, February, and May.

Numeracy Support:

This year we introduced the MIPI (Math Intervention/Programming Instrument) assessment. MIPI is a standardized math test used to evaluate a student's understanding of concepts taught at the previous grade level, at the beginning of the school year. The assessment will also be administered in June and results compared.

Alexis Nakota Sioux Nation Backwoods Energy Services Update



The first quarter of 2024 has seen a concerted effort to align with the budget and strategic objectives set forth by the Management team in the fall of 2023. Progress, however, has been slower than anticipated or desired due to a lack of successful awards and sluggish activity in access solutions. Nonetheless, there is notable activity in forward-looking bidding opportunities, particularly through the partnerships the business has cultivated.

Key project contributions from the Construction and Forestry sectors have been deferred to the second and third quarters, with anticipated results within those respective timeframes. This adjustment has resulted in lower-than-budgeted financial performance in Q1 which is a characteristic environment in the construction sector. Completion of 75,000 M3 of production logging was accomplished over the last quarter.

While Security maintains consistent revenue results, margin outcomes have room to improve. The introduction of additional technology, such as remote digital mobile camera monitoring trailers, underscores efforts to enhance Security operations. This add a new line of service to this business and our existing CCTV monitoring centre in Nisku will provide the monitoring and oversight and will be operational in Q2.

Investment in matting inventory presents opportunities for improved results, particularly in strategically positioned locations like Grande Prairie, Fox Creek, Red Deer, and Edson. Continuous analysis of this business segment's sustainability will inform strategic positioning in the coming quarter. The addition of crane mat manufacturing capabilities, coupled with the strategic partnership with Sterling Crane is expected to give this portion of the Access business a boost.

Backwoods continues to proudly sponsor our Alexin Nation members as they progress through their apprenticeships in light and heavy-duty mechanics at our Nisku maintenance facility.

Formal agreements have been solidified for five of the 2024 strategic priorities and partnerships, with prospects for further opportunities throughout the year. Additionally, two more strategic priorities have been added to the agenda. Management is actively engaged in developing new geographic locations, partnerships with other Nations, expansion of existing services and continuing to look for Merger and Acquisition targets that will support our current operations and propel us in to new.

Despite challenges, the outlook for budget performance remains positive, contingent upon a rebound in the Access business. Construction, Forestry, and Security are expected to perform in line with planned objectives.

Our key tier 1 customers remain Trans Mountain, TC Energy, Keyera, Pembina, Conoco Phillips, CNOOC, Calgary Housing, Canfor, and Tournaline, to name a few.



Financial Performance for Q1 2024

- Sales performance in most categories has improved including lottery, tobacco/cigarette, store, phone cards, gasoline, and CS Coffee sales.
- Direct expenses have remained relatively stable aside from the large decrease in Cardlock, and an \$82K increase in Tobacco & Retail costs for Petro Canada. Overall, direct expenses have decreased by \$924K from Q1 of last year. Gross profit margin has increased from 6.08%, to 11.50% for Q1 this year.
- Inclusive of all factors, there has been a dramatic change in financial performance from the same time period in the prior year. There has been a change of \$168K in net profit, going from a \$36K loss last year to a \$132K profit for Q1 in 2024.



Whitecourt's economy has been slow in the first half of 2024 in keeping with the trend observed in recent years. Most profits have shifted to the end of Q2 and Q3 (from Q2), in alignment with the declining role of oil and gas as a driver in the local economy. In prior times, Q2 featured prominently in the profit timeline due to breakup, which is less of a factor in the new economy, and profits have become more distributed, resulting in less pronounced seasonality over the year. Nevertheless, the upcoming months are expected to be much stronger as a percentage of overall revenues in keeping with this trend.



Gross revenues showed a general decline versus 2023 on a year-to-date basis. This reflects a shift in revenues from stronger performance in April and May to June to August. The revenue pattern has been changed because breakup in the oil and gas sector is much less of a factor in the local economy as that sector has experienced lower activity levels in recent years.




Revenues for April 2024 were lower than April 2023. Revenue seasonality has shifted from March through April as the standout months to June through August, due to shifting economic patterns in Whitecourt. Higher revenues are anticipated for the upcoming period, and the second half of the year is now the driver for financial performance at the property.



Alexis Nakota Sioux Nation Eagle River Casino & Travel Plaza Update



For April 2024, expenses were generally lower than budget and lower on a year-on-year basis. Expenses versus the same period last year were also lower in areas associated with revenue, such as FNDF proceeds.





The property has been focusing on the development of hotel construction drawings, and a package for tender is expected to be presented to Chief and Council within weeks. Interim financing has been put in place to allow the project to progress while construction financing and, subsequently, final project financing, are developed. The property is looking to maximize the grants for the hotel construction as well as other improvements in 2024 and 2025. The major grants being sought are for infrastructure (communications, water, electrical and gas lines, roads, and earthworks and landscaping) and a solar installation. The total funding being sought for these 2 grants is approximately 6 million dollars, but other grants totaling an additional 2.25 million dollars are also being applied for.





Rapid Housing – ANSN - \$27,000,000 85% Completion in Construction

- Atco gas is installing the infrastructure to feed the New Town subdivision. As of June 6th, the primary services have started to each home in the new Town Subdivision.
- LVP flooring is complete in the New Town Subdivision and are currently being installed in the Old Town Subdivision, then we will move onto the remote lots.
- All roofing, exterior door and windows are installed on all precast homes.
- The last 3 homes are being drywalled, taped, mudded and sanded. All of the drywall scope of work is scheduled to be completed by June 18th.
- The interior paint is 65% complete for the precast homes.
- The exterior paint will starting June 10th in the New Town subdivision.
- The kitchens / washroom cabinetry and granite surfaces installation is 52% complete for the precast homes.
- The mechanical rooms are 70% complete for the precast homes.
- Sinks, plumbing fixtures, showers, tubs are 80% complete for the precast homes.
- All the homes in Old Town will be ready to be handed over the Chief and Council by June 28th.
- The skirting of the homes on going in New Town.
- Clean up, caulking and installation of washroom accessories started June 6th.
- Appliance installation with commence in New Town June 19th


YTH Toskamin Awcuyabiti – ANSN – \$17,500,000 75% Completion Pre-Construction
