Alexis Nakota Sioux Nation Message from Alexis Chief and Council

Abawashded Mitaudebi,

This report is presented to the Alexis members during the 4th Quarter Band Meeting on Friday, March 17, 2023 of the 2022-2023 fiscal and operating year. The report accounts for our office and activities. We have included the Financial Statement for this quarter. We are pleased to inform the Membership that in August of 2022, we created a new construction management company called 'Hill Plain'. Hill Plain is our lead construction management company and is currently managing several projects.

During this last quarter, we spent some time visiting with the Elders and members on our Agricultural Benefits Claim. As we negotiate through our claim, we are inviting members to give us feedback on their concerns and suggestions for a potential settlement. On all areas of the nation business we will make every effort to keep our members informed on through community meetings and quarterly reporting. Here are some highlights for this reporting period:

- **Alexis Nakota Sioux Nation Agricultural Benefits Claim (2017):** In December 2022, our legal team confirmed we are in negotiations. We started having community meetings on January 19, 2023 and will continue this process until we receive our claim. Based on these meetings, Council will develop a list of priorities and present a proposal to the membership for consideration.
- **Pasa Tibi Center (2020-2024):** We are one step closer to having our new Elders lodge. Corrine Potts, Project Manager has been working on this project since 2021 and we are in the final stages of receiving \$22 million in funding to begin construction. Training and employment is a huge benefit to this project. We look forward to a groundbreaking ceremony in June of 2023.
- **Alexis Nakota Sioux Nation Constitution (2019) "Odaagina Nimi":** Council has been working with Chasidy Alexis, Socio-legal & Policy Analyst on drafting our Constitution. (For more information see pages 10-12)
- **Traditional Healing Conference (2023):** We are preparing to host a Healing Conference in Edmonton on May 23-25, 2023. Janice Alexis is the Conference Coordinator and is working with a Committee to organize and plan. This conference is open and will bring together various speakers and experts on Traditional Healing, Mental Health & Wellness.
- **Hill Plain (2022):** Hill Plain is currently managing the following projects for our nation: Nakota Wohnabiti (Cultural Interpretive Center), Youth Transition Home,, Pasa Tibi Village, North Water & Sewer Extensions (4 Phases), CN Rail Transload Project, Community Asset Restoration Project, LSAC Culvert Replacement & Rapid Housing Initiative CMHC Phase 3. We are very pleased with the outcome and look forward to our members having more opportunities. (For more information see page 26)

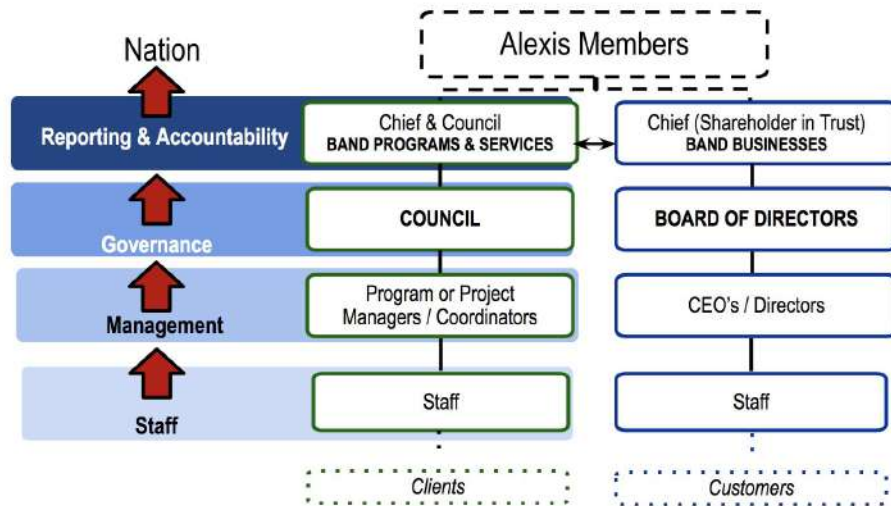

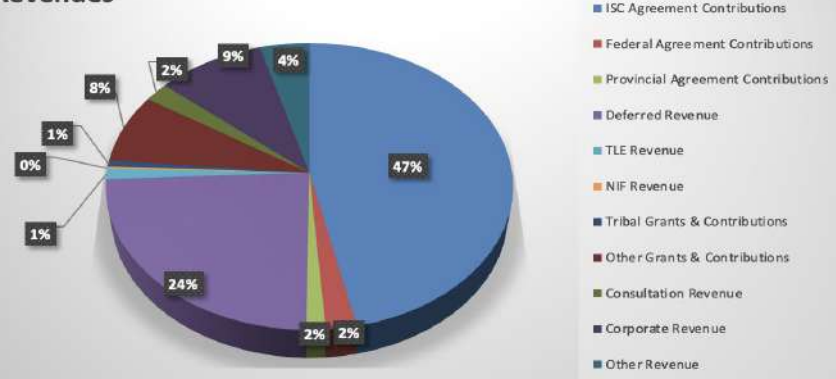

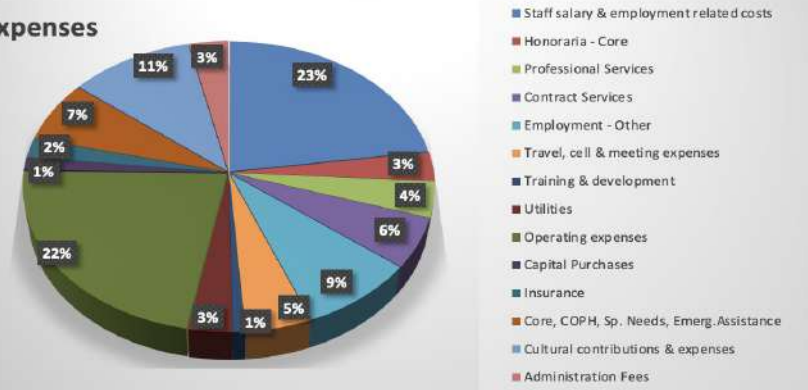

Alexis Nakota Sioux Nation Treaty - Agricultural Benefits Claim Update



UPDATE BY GARRY T. LABOUCAN, PARTNER - THOMPSON, LABOUCAN & EPP LLP

Chronology of Alexis Nakota Sioux Nation claim for Agricultural Benefits pursuant to Treaty 6

- 2015 - Alexis Nakota Sioux Nation (“ANSN”) retains legal counsel to explore a possible claim based upon the promise of Agricultural Benefits under Treaty 6. Legal counsel retains expert historian, who provides a report late 2016.
- December 4th, 2017 – Legal Counsel draft and submits ANSN’s claim for Agricultural Benefits to the Specific Claims Branch.
- February 8th, 2021 – ANSN signs Information Sharing Protocol Agreement with Canada with respect to the ongoing mediation between Sunchild First Nation and Canada. The mediation sought to develop a framework compensation model for Treaty 6 First Nations that had similar claims for Agricultural Benefits.
- February 26, 2021 – Canada provided a partial acceptance of ANSN’s Specific Claim and offered to negotiate on that limited basis.
- December 10, 2021 – ANSN files claim in the Specific Claims Tribunal seeking full compensation for agricultural benefits.
- June 8, 2022 – ANSN files Statement of Claim in Federal Court. This claim was filed as a precaution, as the Specific Claim Tribunal has a monetary cap of \$150 million. The Federal Court Action was put into abeyance on August 10th, 2022.
- Fall 2022 – Mediation between Sunchild and Canada concludes. Mediator prepares final report.
- December 6, 2022 – ANSN Chief and Council meet with Canada’s Director of Specific Claims to discuss possible settlement.



Alexis Nakota Sioux Nation Odaagina Nimi Update



“Alexis Legal Traditions & Cultural Ways of Social Ordering”

BACKGROUND:

A Governance Committee of thirteen life-givers has been selected by Chief and Council to have demonstrated their commitment to serve the Nation, steward Lands and Waters, and keep the Language alive. This committee will guide and facilitate strategies to implement Odaagina Nimi in collaboration with leadership, project staff and department managers. As leaders within each of their respective clans, the Life Givers Committee will be an influential conduit for information to flow between the community and the implementation team. Since 2019, it has become increasingly evident that ongoing, community-wide engagement is required to fully realize and implement Odaagina Nimi. Despite having worked extensively with Elders, a great deal of communal knowledge now resides within the descendants of Elders who have now passed on. While recovering knowledge from Elders is not only essential but timely in this process, we must also work more diligently to nurture and remember the teachings carried by younger generations.

Meeting Highlight:

Community presentation of Sioux Valley Dakota community self-governance and constitutionality of the Dakota Oyate in Sioux Valley Manitoba. Sioux valley presented on community nation building, sovereignty, the white buffalo calf honoring ceremony, and community governance law making. Exp, Citizenship Law, and the Dakota Oyate Constitution.

Key Point: Sioux Valley does not have a treaty, the negotiated a self-government agreement directly with the Government of Canada and maintain sovereignty over Dakota Oyate lands.



ODAAGINA NIMI IMPLEMENTATION MANDATE:

Apply Alexis Nakota traditional modes of community governance in all thirteen sections of the Alexis Nakota Constitution Project.

The Alexis Constitution project began with a mandate to initiate a preamble that sets forth the rights and obligations of Alexis Nakota Peoples ways of living on Alexis Nakota Lands.

At present we have evolved into spiritual wholistic community-based methodology of implementing Alexis Nakota traditional governance, based on the foundational Nakota language term, 'Odaagina nimi', which translates to bringing balance with a good mind, health and life. The Odaagina Nimi project is guided by Alexis Nakota ancestral cultural knowledge, historical research and oral history of the Alexis Nakota Community. Throughout the foundation of this project the executive committee presented the question, "how is our current governance structure guiding our Nations spiritual, economical, social and cultural growth?".

Today we are in the implementation phase of Odaagina Nimi, our time-line of completing Odaagina Nimi is projected to four years in order to be fully operational in our Alexis Nakota governance structure.

Our governance committee of community members will assist our Nation in the final draft of Odaagain Nimi. Our Odaagina Nimi. The Governance Committee members were selected to guide the implementation process in community nation building. agreement and attach if completed.



Alexis Nakota Sioux Nation Odaagina Nimi Update



IMPLEMENTATION GOALS:

1. As instructed by our community elders in the previous phases of Odaagina Nimi development, the implementation phase must be entirely non-western in its structural foundation and culturally-spiritually wholistic to the Alexis Nakota Nation protocols of traditional governance.
2. Any western legal terminology to be included will be at the request of Chief & Council, Elders, Traditional Knowledge Holders, Life Giver committee meetings, or community initiatives or local policy directives.
3. Our life givers committee maintains a de-colonized lens when interpreting the cultural foundations of Odaagina Nimi. Our members meetings are being captured by our cultural liaison and guided by our cultural community advisor.

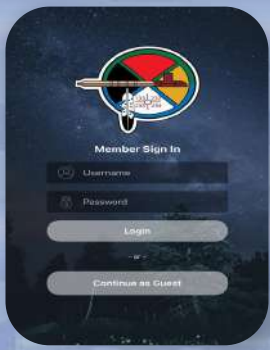

Executive Overview

The Backwoods group of partnerships (“Partnership”) and business structure includes three wholly owned Limited Partnerships (“LP”), which are managed by a general partner (“GP”), being Backwoods Energy Services GP Inc. (“GP”). The three LPs are:
Backwoods Energy Services Limited Partnership (“BES LP” or “Energy Services”)
Backwoods Security Services Limited Partnership (“BSS LP” or “Security”)
Backwoods Matting Services Limited Partnership (“BMS LP” or “Matting”)

Market segments of the Partnership are upstream oil and gas, forestry, pipelines, and site services. The primary services include:

- General light civil construction up to 40 ton, including lease and road building, deep undergrounds, buried utilities, and dewatering.
- Environmental support including reclamation, remediation, and project management.
- Security services including all dimensions within retail, commercial, institutional, and industrial environments.
- Forestry including brushing, clearing, seismic, rights of way, horticulture, and silviculture.
- Access solutions, including matting fabrication, sales, installation, and rentals of all types of products and solutions.

Effective June 15, 2021, Backwoods is owned 100% by the Alexis Nakota Sioux Nation.

The Partnership's primary purpose is to provide financial resources to the Nation as well as employment opportunities for Alexis's members and other Indigenous peoples.

Backwoods 30 by 30 – Alexis Recruitment plan

The Executive team has identified building Alexis's employment and contributions within the business as a key strategic objective. The program has started the 30 by 30 initiative with the goal of achieving 30% Backwoods head office personnel being Alexis's members by 2030. Key initiatives in the quarter included development of a plan, office move at Alexis, physical presence on site weekly at Alexis, development of relationships with key stakeholders and interaction directly with potential Alexis's members looking for employment.

Operational and Financial Highlights

The partnership is currently on target to hit the projected budget for 2022.

Q4 of 2022 was an exceptionally busy quarter for the business. All segments of our business were running at full capacity. Execution of backlog and work in progress (WIP) through three major projects (TMEP, TC Energy, and Keyera) continued. We have also started work on a new pipeline for Arnett and Burgess in East Central Alberta in our matting division. Substantial planning has taken place on the production logging program with Canfor with work now started on the Wo1 and W02 production logging, logging 15 to 20,000 m3 of lumber that will move to the Whitecourt Canfor facility. There will be two discussions on open careers coming in the following month. This new venture is part of the company move to 50% MRO, 50% major capital construction.

Another milestone took place in Q3 where Backwoods was given approval by the County of Leduc to start operations on a commercial basis on fleet maintenance, which will be a further move into the MRO markets and provide good apprenticeship and journeyman careers for Alexis's members. Backwoods also started the repair of the pipeline spill with Pembina at the Whitecourt corner, this work is expected to take 8 weeks to complete, and then reclamation another 8 weeks through the summer.

Commodity prices stayed strong through the quarter, which allowed the continuation of major projects. The western Canadian basin activity has increased dramatically over the same period in the prior year and the Partnership is experiencing improved demand for its services. New Major contracts have been won with CNOC and Suncor in Fort McMurray.

Backwoods is currently going through its yearly audit, but preliminary numbers show that the company has achieved its budget targets and has had a very successful year on operations, safety, and execution of work for our customers. Final numbers for 2022 will be provided on or before April 1st, 2023.

Civil – The Civil business unit started work on the Pembina spill reroute. Backwoods has received its ABSA certification allowing it to weld and complete pipeline construction on its own, away from its previous Steel River alliance. This is a major move for the company in securing future activities. Work is taking place at Chevron, and with Keyera on the civil business.

Forestry – Forestry continues to be strong in building a new business, we are currently working for Chevron, and Canfor in multiple locations. New equipment is in the company to allow full execution of production logging, which will now be a full time all year venture. A great opportunity for Alexis's youth to join the company with a new venture.

Matting – Matting had a record year in sales, production of mats logistics and rentals. It continues to be a core part of Backwoods. Backwoods is now starting to build crane mats on site at Nisku and within 2023 will start production of rig mats as well. The facility produces on average 1100 mats per week.

Mechanical – The Mechanical group is busy with Transmountain, Keyera and Pembina on integrity digs and spill cleanups. A very solid year for this group in 2022 and continued expectations for continuing in 2023 in routine maintenance.

Security – Backwoods has won the Conoco and CNOc security awards and will now have a full-time office in Fort St John BC as of Feb 1, 2023. This is a significant move for the company into a very strong industrial area, the Motney gas field.

Site Remediation Program – The conclusion of the initial phase of the program ends on February 14th, 2023. It is now expected that producers will continue to spend based on their mandated spend with AER and that the program although changed, will continue to be strong for years to come. This is a significant focus for Backwoods in 2023. We finished the program with over 125 million in grants managed in the program, by far the largest of any Indigenous contractor.





Alexis Nakota Sioux Nation Eagle River Casino & Travel Plaza Update



Overview

Operations in December and Q4 performed well, with year-over-year increases in most areas. Both periods showed stronger demand for casino and related products, while sales at the gas bar fell off for December and over the quarter.

Inflation and low unemployment continued as the dominant economic concerns, with consequent unease about the effects of interest rates on the economy in 2023. Nationally, inflation rose 6.3% year-over-year in December, down from 6.8% in November. Provincially, unemployment registered at 5.8%, which, while down from 7.5% a year ago, is trending upward on a monthly basis. More recently, the expectation of a “soft landing”, curbing inflation while navigating to a mild recession or no recession at all, has seen increasing support. Very recently, the Bank of Canada has hiked interest rates by 25 basis points while indicating that no future hikes are on the immediate horizon as disinflationary influences emerge, such as lower oil prices and the opening of supply chains with the change in China’s Covid 19 policy.

Nevertheless, in the short term, inflationary pressures are presenting on several fronts, most notably as wages and benefits. There are a number of long-term vacancies will require a rethink of compensation, including benefits, if qualified candidates who can add to the business are to be recruited. As noted in a prior report, Whitecourt has been recognized by the province as a community that is eligible to participate the Alberta Advantage Immigration program, which allows businesses to bring in foreign workers with a path to permanent residence. Whitecourt has asked for a letter of support from Woodlands County for the inclusion of Eagle River Casino & Travel Plaza in the program, but the County has deferred thus far.

While uncertainty around the economy persists, the outlook is becoming increasingly optimistic on all levels, including locally here in Whitecourt as the earlier expectations for a recession in the first 2 quarters of 2023 diminish.

Projects and Updates

IT

The transition to the cloud is progressing, however the support from the IT provider with respect to this project has not been energetic. Nevertheless, benefits in terms of costs and reliability from the transition is already being achieved. Additional projects are being undertaken, including RPA, to drive out costs and enhance the accuracy of internal process and data handling.

Property Operations

The upgrade mentioned in a prior report enabling the PLC to be remotely monitored has been completed ahead of schedule. Operators can now take readings from the pumphouse directly from computers at their desk.

Food and Beverage

Food & Beverage had a very successful December and fourth quarter, during which some equipment was purchased to enhance public safety and food presentation. December sales increased by 48% versus December 2021, and by 62% versus Q4 2021. Some of the increased sales resulted from changes in health measures, but customer confidence and a return to normalcy also affected sales.

New projects scheduled for implementation include:

- Applying to make the restaurant “minors allowed”.
- Enhancing buffet service and equipment.
- Reintroducing Friday night food specials.
- Exploring the redesign of the bar.
- Developing a new brand and service model for the restaurant.

Travel Plaza

The Travel Plaza operations has been improved overall with the assistance of a consultant. One area of immediate focus is to improve the speed and quality of management reporting, and to enhance understanding of the financial relationship between internal profits and Husky pricing decisions.

Gaming

Table Games performance came in on budget for both periods. Slots has performed consistently well. Although Coin In was significantly below budget, much lower marketing investments offset the difference in projected revenue. Slots revenues were up by 28% versus December 2021, and Table Games revenues were up by 17% over the same period. Combined wage expense for both departments were well managed, contributing to strong overall results. Table Games will open on Mondays and Tuesdays commencing January 31st, 2023.

RV Park - RV Park occupancy trended seasonally to annual lows, as campers relocated for the winter. Winterization and leak control were very well managed. Graveling and sloping efforts resulted in no roadway issues for the period. Smaller projects to be undertaken include the repairs to the bathroom building and replacement of rails in the main building. Major projects include the design and build of 2 rental prototypes for the RV Park. Most of these projects will be deferred to spring.

Other Matters - Below is a list of certain open positions and the date they were initially advertised by Human Resources:

- Security Manager – 2022, April
- Executive Chef – 2019, August
- Casino Shift Manager – 2016, January
- Marketing Manager – 2018, June

These are difficult positions to recruit to relocate to Whitecourt since there is a demand for these positions in the bigger towns and cities. Compensation, and particularly benefits, will have to be enhanced if capable candidates are to be motivated to seek employment at the casino. The LMIA process is not achievable for most of these positions as the Government of Canada target wages cannot be met by the property. For example, the median wage required for a Security Manager under this program is over \$98,000, and the Marketing Manager is almost \$100,000.

CBRE is expected to finalize their report on the hotel environment in Whitecourt. It is likely that the report will speak to the challenges in this market. Preliminarily, the target cost-per-key has been calculated at approximately \$170,000.

Summary

After a slow start to the year with very low revenues in January, the property rebounded and continued its strengthened performance through the remainder of 2022. Overall, the casino closed the year 20% ahead of budget, exceeding the 2019 pre-Covid performance and rivalling 2018 EBITDA.

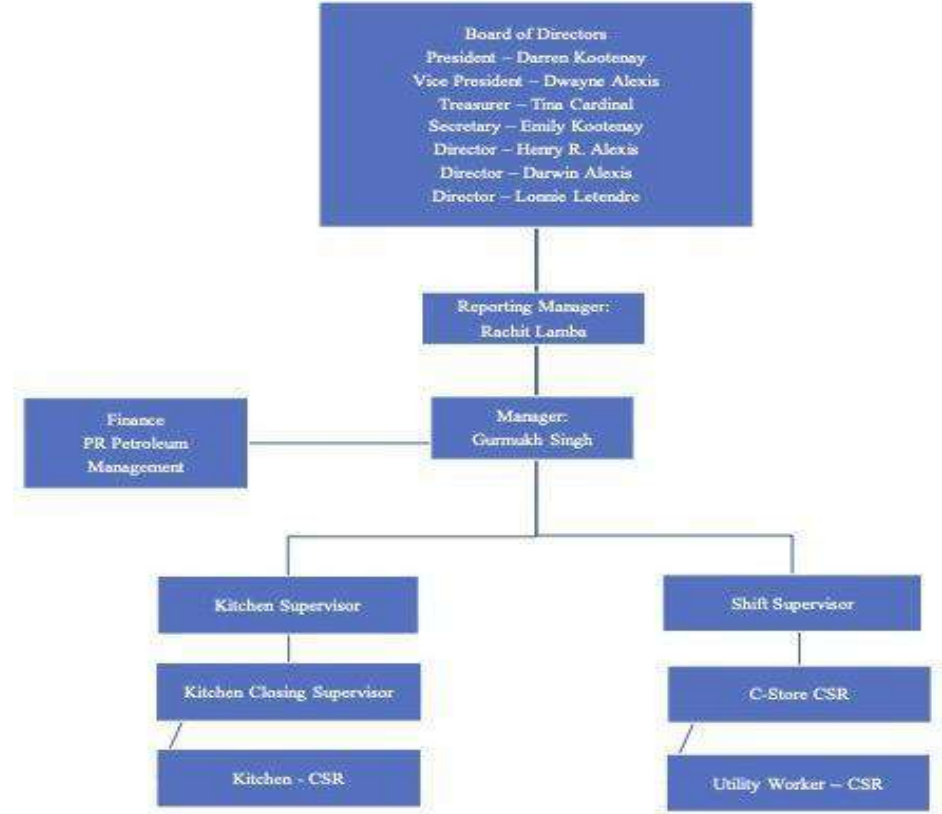
A new manager with more experience in the food service industry will be coming in to replace the existing manager on 15th of February.

Hill Plain Background:

Hill Plain is a Construction Management Services Company (Owner Representative) that is wholly owned by Alexis Nakota Sioux Nation (ANSN). The purpose of the company is to fully manage design through construction (and source funding) of on-reserve and off-reserve large-scale building and construction projects.

Hill Plain also serves to advance economic development opportunities and partnerships for Indigenous communities, including Alexis Nakota Sioux Nation.

Many Indigenous communities lack the capacity to access the resources needed to build large scale on-reserve infrastructure projects and when they do, they are often excluded from important stages of the project.

Hill Plain serves to address this issue by building capacity for ANSN to manage their own projects while ensuring that Indigenous people and more particularly ANSN members participate in projects from the beginning to the end.

ANSN now has the capacity to be involved in all stages of a project, from securing funding to design and construction while ensuring the projects reflect our history and cultural values.

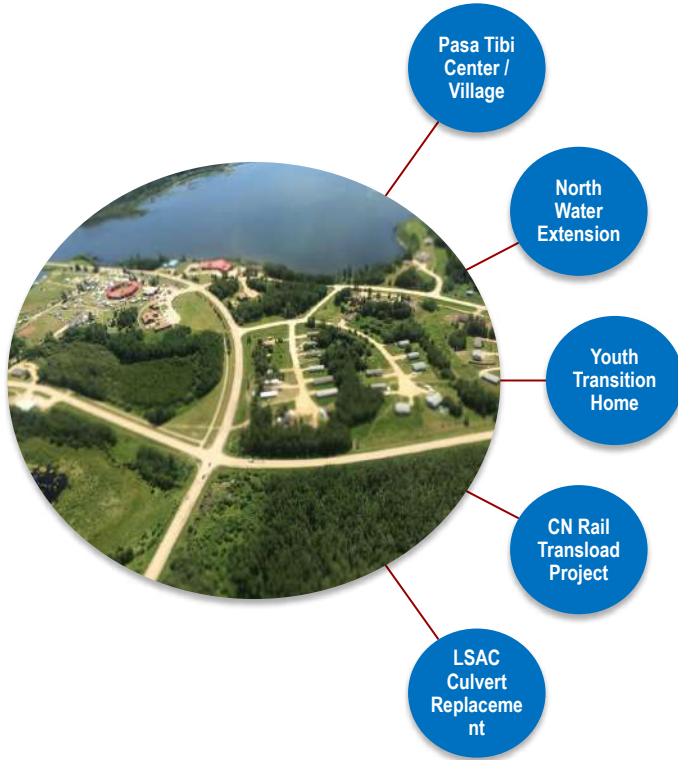

Alexis Nakota Sioux Nation Education Board Update



Teaching and Learning

The continued focus is literacy. Since September, reading assessments have been conducted with all students. From those results, students were grouped based on their reading levels and needs, support would be provided individually or in a small group setting. Currently, 47 students receive literacy support by Krista Dallmann and/or Margaret Petawaysin. Through this program we have seen growth in students' sight word recognition, vocabulary, reading comprehension and literacy levels. These small group settings have allowed students to become more confident readers, they are more willing to take reading risks. We also implemented whole class intervention from Grades K-1. This includes helping to develop a strong foundation in literacy through phonics, phonemic awareness, fluency and vocabulary.

Social and Physical Environment

Playground Project - Pembina Pipeline and support from Inclusive Education and Indigenous Services of Canada, to support the development of a Kindergarten to Grade 6 playground structure during the summer of July 2023. Education is seeking partnerships for the removal of the existing playground and preparation of the footing for the new playground structure.

Policy and Procedures

We have hired another individual, Shannon Lust, who will assist with the policy. Ms. Lust has identified a number of gaps in our school policies and has created a number of new policies & procedures such as a bus driver handbook and safety manual. Once complete, the board will review and approve the final policies. Through this process, we will implement them as soon as the final draft is approved.

Partnerships and Services

Hope and Healing Conference at ANSN School - April 21-23. The Hope and Healing Conference will invite youth and community leaders from across Lac Ste Anne and Parkland County to gather together for two days and answer the question, "What does it take for our community to foster hope and healing in the tri-municipal region?" Conference is being planned for 250 children, youth and families. Financial support is needed to support food, entertainment and community members with lived experience to join the event.

Science and Innovation Project - Gairdner Alberta Programming funding will support the development of Youth Leaders who will structure and plan for the April 21-22 Hope and Healing Conference being hosted by Alexis Nakota Sioux Nation High School. These students will also tour the Faculty of Medicine and Dentistry, Secondary Education and meet Indigenous academics who are involved with research and community development efforts to protect the land and Indigenous peoples.

Alexis Youth Leadership Council - The Alexis Youth Leadership Council will involve Grades 8-12. 6-8 youth will be invited to interview, apply and train to support youth perspectives on and off the nation. The chosen youth will have the opportunity to travel to Youth Hubs, Municipal meetings and youth activities offered by the province.

Jumpstart Physical Literacy Projects - Canadian Tire Jumpstart provides financial support so that all children and youth can be involved in sport and recreation. The winter programming at Alexis School will include downhill skiing, ice skating, boxing, equestrian therapy visits, yoga and Friday night youth volleyball in Spruce Grove at the TransAlta Tri-Leisure Centre. This funding is applied for in partnership with Change Health Alberta.





Alexis Nakota Sioux Nation Nikoodi Daycare Update

Updated as of February 17, 2023

The daycare is still following some of the covid guidelines we will continue to have a drop off and temperature check at the door daily.

The daycare is open to children at 8 am and close at 4:45 Monday – Friday daily.
Daycare also has a drop in service daily after 9 am with a \$ 35.00 drop in fee for the day.

Nikoodi daycare runs a school readiness program which is age appropriate for 38 months to 5 years of age (preschool room). Our Toddler room has the same program which is designed for 38 months and under. The program is a learn through play involving the language, culture and smudging daily. The use of basic commands small sentences, colors, numbers, animals and the weather are done daily. The staff have labels all around the room to show what objects are such as table, chair, book shelf, doors cubbies. Our yearly program is determined by our weekly themed calendar for the year example all about me, bus safety, fall leaves example, all of which have some sort of language component. Some of these theme would include field trips however we do not have transportation (bus/van) to accommodate our outings.
